#### Data Protection in Environmental Management

#### This includes:

- Ensuring that personal data collected for environmental training, incident reporting, or monitoring is processed lawfully and securely.
- Limiting access to personal data to authorized personnel only.
- Embedding data protection principles into environmental management systems and procedures.
- Ensuring that third-party providers involved in environmental data processing adhere to GDPRcompliant standards.
